Dear Sir:

Re: Yasumatsu Yoshida, Deceased.

We enclose herewith Custodian cheque in the sum of \$7.93, being the balance of funds in the account of Yasumatsu Yoshida, deceased, in this office.

These funds are sent to you to apply upon the funeral expenses advanced by you.

The document which you called a Death Certificate and asked to have returned to you is not really a Certificate of Death but is just a form upon which certain particulars have been filled in by the Department of Labour. This has the funeral expenses itemised on the back which we wish to retain in justification of sending you the enclosed money. If you wish to obtain a proper Certificate of Death you may do so by applying to the Vital Statistics Branch of the Provincial Government at Victoria, B. C.
