We wish to acknowledge yours of November 24th and have been able to identify this family as Kiyemon IRIE, Registration No. 00312, File 2123, and his wife, Koyasu IRIE, Registration No. 00496, File 7664. Others named in your letter are their children.

The names of the children according to our records are Isamu, son, age 12; Masako, daughter, age 20; Eriko, daughter, age 18. We have no record of any one by the name of James as stated in your letter, but Mr. Kiyemon IRIE in his declaration listed a son by the name of Teruyashi, who would now be 25 and another son Hiroshi, who would now be age 16. Possibly either one of these boys have been known as and has adopted the English name of James.

Mr. IRIE and his family are not Internees. They were evacuated from this area of British Columbia and his address according to our records is given as SLOVAN CITY, B. C. We have no objection to you dealing direct with Mr. IRIE in connection with this life insurance.

Incidentally we received a letter from Kiyemon IRIE dated May 22nd last in which he asked us to pay premiums to your company on his insurance and on June 9th we sent cheque to your Vancouver
