In the above Evacuee's declaration form, dated May 4th, 1942, it is revealed that Eriko Irie declared \$200.00 in a Savings Account with the Royal Bank of Canada, Marpole Branch, Vancouver, B.C. Nothing further in connection with this money is found on file.

A \$500.00 Prudential Life Assurance policy is also declared, beneficiary being Koyasu Irie, mother, and this policy is stated to be in the mother's possession. The father's file, number 2123, reveals that all payments of premiums are made from the father's account.
