In your registration with the Custodian you declared personal property at 722 East Pender Street.

With the purpose of offering protection to your chattels, our representative visited your former address and was informed that everything had been removed with the exception of one old stove of insufficient value to justify the moving expenses. We have therefore allowed the stove to remain where it is.

We assume that you have sold or disposed of the balance of your chattels and that, apart from the stove, you have nothing remaining in the restricted area of British Columbia requiring our protection.
