





We have received your letter of April 23rd enquiring about policies on the Uyeda family. According to our records, the above numbered policies are the ones to which you refer.

Policy No. 885,404: as at the last premium due date which was October 1, 1944, there was an automatic premium loan of \$76.99 outstanding plus the current net premium of \$35.61. Interest on the foregoing amounts will be payable at five per cent per annum until the date of payment. This policy is still in force and would carry through to maturity which is October 1, 1953, even if no further payments were made.

Policy No. 2,122,099: the current premium on this policy falls due on May 1st in the amount of \$54.45, less a dividend of \$5.49. This leaves \$49.06 required in cash to pay this premium. There is no indebtedness against this policy. X

Policy No. 2,268,682: this policy is paid to date with the next premium falling due on February 1, 1946. There is no indebtedness against this policy.
