Thank you for your letter of September 28th.
re the above party. Our previous letter of September 25th.
possibly does not cover this situation quite as clearly as
it might.

Before the Hashimotos left 233 Ewen Avenue
they handed us a list of articles which they wished removed
from this address. This list is made out in their own hand-
writing and is still in our possession. It tallies exactly
with the list made by Belyeas' when they moved the furniture
shortly after the departure of the Hashimotos. We believe,
therefore, that this relieves both your office and our own
of any responsibility in connection with the numerous
articles declared missing in their letter to you of Sept. 22.

There is a possibility, however, that these
missing articles are stored in another location and this
location may be determined from the Japanese themselves in
which case we would be glad to investigate further. It
seems logical, on the other hand, that they would have in-
cluded these articles on the inventory they left with us
before their departure.


We have now in our possession the JP form re the above man and wish to advise that on May 15th we wrote you saying that he owned barber shop equipment located at 741 Front Street, this city.






