Mrs. Tyler of the Department of Labour, Japanese Division, Vancouver, has informed us that Mrs. Murakumi (Incore) stated to the R.G.M.P. that she was married in Japan twice prior to her arrival in Canada and that in each instance it was a Yoshi Marriage and that the husband in each case married into her family, taking her family mass of Marakumi, the first husband being Socuke (surname unknown) and the second being Shine Incore. Shine Incore's last known address is New Deliver, B. C. as reported March 23, 1945.


