This file reveals that NAKATSURU owned no real property in any protected area of B.C. and did not carry any Fire Insurance.

CHATTELS:

NAKATSURU registered with the Custodian on May 5/42 and was evacuated on May 22/42. He signed a yellow "No property" card stating he owned no property of any kind whatsoever in any protected area of B.

However on Feb. 2/44 the B.C.S.C. sent us a letter written by NAKATSURU to Mr. Rajecevich of 2222 Napier St. asking for shipmen t of two boxes of kitchen utensils he had left with him. One box of kitchen utensils was shipped on 22/2/44. This apparently did not belong to Mr. NAKATSURU as noted in letter from B.C.S.C. of March 21/44.

On April 10/44 we received Custodian release asking for shipment of one large box and 2 small boxes of kitchenware in the care of Mr. najecevich. These were shipped 26/4/44. As we received no further correspondence from NAKATSURU on the matter, it may be assumed these were the correct boxes. However the file does not explain what happened to the first box that was shipped and which NAKATSURU said did not belong to him.

Specified Articles:

The Westinghouse mantel radio surrendered by NAKATSURU to the R.C.M.P. was handed over to the Custodian on Jan. 27/44. It was sold at suction for the net sum of \$38.92 and this sum credited to the account of NAKATSURU. This is his only credit with the Custodian.

No property interests other than those mentioned above are found on this file.


