Prior to my evacuation from Vancouver to Chase B.C. I left a tool chest (initials K.T. on top) in the attic of the Japanese United Church, 500 Powell St. I understand that the aforesaid premises are now under lock and key, and have been for some time. To make matters more complicated, the chest was registered by my mother, Mrs. Kuno Takahashi before she left for New Denver in the late fall of 1942.

I would like to know if it is at all possible to have this tool chest sent to me, and if so, what are the necessary steps that I must take to obtain it.

It does seem futile, considering all the bother entailing its removal, both in the legal aspect & the actual getting and sending of the article, but I am writing you - just in case - as I am desperately in need of those tools.
