In her letter of June 2nd, 1943, she states that she had disposed of the washing machine and one bed with spring prior to her evacuation. She also advises in this letter that her other goods had not been taken with her but had been stored at 1642 West 2nd Avenue and that they were labelled with the name of S. SAIGA and W. SAIGA. A representative of the B. C. Security Commission along with our own representative searched at this address but failed to find any of the goods belonging to the above.
