This man signed a declaration to the Custodian on May 7, 1942. He was evacuated on May 22, 1942.

In his declaration he reported a radio in custody of the R.C.M.P. This radio was released to the B.C. Security Commission on August 24, 1943 for shipment to MIYAZAKI.

He reported a bank account in the Royal Bank of Canada with a balance of 16 cents. This did not come under the control of this office.
