This 27-year old Canadian-born Millhand from Woodfibre, B. C., signed a Custodian "JP" declaration form on the 4th May, 1942. He was evacuated in May, 1942. He was single at time of evacuation.

Bank Accounts: None.


Life Insurance: None.
