- CHATTELS: The above, who made his declaration to the Custodian on May 4/42, and was interned on May 22/42, declared no chattels.
- At the request of the above, his three ten dollar War Savings WAR SAVINGS CERTIFICATES: Certificates were cashed and the proceeds from sale of same in the sum of \$24.00 was remitted to the Commandant, Angler Internment Camp on November 19/42, to be applied to the account of ITO.
- INCOME TAX: A refund of income tax for 1942 in the sum of \$32.52 was received from the Provincial Collector in favour of the above, and this sum was forwarded to him on July 29th, 1943. On October 11th, 1943, ITO wrote and advised us that he had not received his refund of income tax for 1941. In our reply dated October 18th, 1943, we gave him the address of the Income Tax Division and suggested that he write them direct regarding this matter.
- The above declared a savings account with the Japan and Canada Trust JAPAN & CANADA TRUST Company in the sum of \$100.00, but an examination of the list of depositors in this Company fails to disclose his name, so it would appear that he withdrew his balance there between the date of his registration and the date of his internment.


