This woman signed a declaration to the Custodian on May 4, 1942. She was evacuated on May 12, 1942.

In her declaration she reported a list of chattels stored at Woodfibre. These are handed on the file of her husband, File No. 806, and show that some were shipped to them, an electric machine is unaccounted for, a stove was discarded and the remainder were sold at auction and the net proceeds credited to the account of her husband and remitted to him today. Chattels are shown on the Chattel Schedule immediately following.

This file reveals no other property of any kind.
