He reported a \$50.00 Victory Bond and twenty-four \$5.00 War Savingson Certificates in his own possession. He reported a bank account with the Royal Bank of Canada, Vancjuver with a balance of \$1,200.00. He reported a \$1,000.00 life insurance policy with the Sun Life Assurance Co., the policy in his own possession. None of these items came under the control of this office.
