Mr. and Mrs. Kawabata came in to the office and stated that the above goods with the exception of the sewing machine, belong to them, but were not included in their original declaration. They maintain that the gramophones (2) and lawn chairs (2) were left in the house and there was also left (undeclared) 1 tin Japanese sauce (4 gals). They claim that 1 trunk (dark brown) of clothes and 1 box of tools (carpenter's), about 15" x 20" x 36", (locked) and 1 sewing machine (as above), belonging to Mrs. Wakabayashi (File #8229) were left in the house when they left. They claim that the trunk and boxes of tools shown on their original declaration do not belong to Mrs. Wakabayashi.
