We are in receipt of your letter of the 10th of March and note your most hostile remarks. We most absolutely disagree with the claims you have lodged against us. In the first place, we of the Nishimura have had no such contact with the said Doctors McLean and Hoie and in the second place the said accused person Miss Hirany Nishimura has never been ill in her life and never not even a hour had she had to stay away from work on account of illness during her years of steady employment. I really do not know how you could have dug up this ridiculous claims unless you are dreaming in this time above all of us time. Of course you are in knowledge of that we have the power to take up action in court against you for slander suit.

Immediately upon receiving this letter please supply me with the addresses of Doctors McLean and Hoie in order that I may send them a letter stating about this claims. I wish that you notify the above named doctors too of this business. Trusting to hear from you remain
