MEMORANDUM May 16th, 1944. File Nos.: 8241 2902 FILES To: Prom: Mr. Green Re: Mr. and Mrs. Tatsuya TANAKA The wife, file 8241, declared a number of household effects left at 715 West 7th Avenue, being the Pairview Buddhist Church. The husband, who declared no-

thing, applied for shipment of boxes and a trunk from the same place on April 20th, 1943. Shipment of these was made but some of the contents were missing and some broken.

There seems nothing to add at this stage to our letter of June 18th and Mr. W. L. Brown's letter of June 23rd on file 2902. This latter file may, therefore, be regarded as closed and effects declared by the wife followed up on her file only, when time permits, and the state of our storage places permits access to her belongings.
