Received your letter of February 29th, informing me that a certain party by the name of Ichiro NAKATSUKA has made a claim with your department for the sum of \$98.89.

Kindly acknowledge that prior to evacuation, I had been attending school in my home town, and therefore never had an opportunity of becoming indebted to anyone, especially a complete stranger, for such a huge sum.

I am not intending to pay the supposed to be debt to a stranger from God knows where and besides I have not any sum of my own to do so. I have taken for granted that it is an error on your part.
