In her declaration, Mrs. Kobayashi reported four boxes of effects. On August 10, 1942, she signed a Custodian Release for these goods, and it is assumed that these were taken with her upon her evacuation.

Mrs. Kobayashi reported a debt owing to her by Mr. K. Nakamura, 446 E. Cordova St., Vancouver, in the amount of \$130.00. This claim was settled in full for \$80.00, which, with Mrs. Kobayashi's approval, was credited to the account of her husband, File 14788.

The net proceeds from the sale of a motor-vehicle belonging to Mrs. Kobayashi's husband was in error credited to her account, but was later transferred to the account of her husband.
