We enclose herewith Custodian cheque in the sum of \$15.91, being your entire credit balance with this office, and we are therefore closing your file.

Your file has been reviewed and the following is noted. When you made your declaration to the Custodian on May 9th, 1942, you declared one box containing household effects left at the World Hotel. This box was removed to Custodian warehouse and the contents sold at auction for the net sum of \$15.91, and this sum credited to your account with this office.

You declared an insurance policy with the Western Mutual Benefit Association in the sum of \$500.00. This policy was not brought under the control of the Custodian.

We are holding for your account two hundred and twenty five shares in the Japan & Canada Trust and Savings Company. We would advise you that no distribution has yet been made to the shareholders of this Company.

In accordance with the request contained in your letter of May 8th, 1943, we paid a claim in the sum of \$6.00 filed against you by Dr. SHIMOMURA with the money you sent us for this purpose.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian, and in order that you may confirm this and acknowledge the cheque, we are enclosing a stamped addressed envelope for convenience in replying.
