Dear Mr. Gyms:

Re: Policy No. 2,391,675

We have received your letter of May 27th telling us that you can not make any payment on your assurance at the present time but would like to borrow as much money as possible. If you take the maximum loan which is about \$90.00 your assurance will only remain in force until April 3rd. 1944, the next premium due date and at that time it will be necessary to pay the premium then due together with the interest on the loan in order to keep the policy in good standing. If you see no prospects of making such a payment next April then you might wish to take the Cash Surrender Value now. The Cash Surrender Value is about \$92.00.

In order to obtain the loan of \$90.00 the attached agreement is to be signed by you where marked "Assured" and by your father as Selva Gyms where marked "Beneficiary". Both signatures must be witnessed by someone outside the family and such witness will show his address and occupation in the appropriate spaces.

Should you decide to take the Cash Surrender Value instead of the policy loan then the attached application for Cash Surrender Value is to be signed by you where marked "Assured" and by your father as "Selva Gyms" where marked "Beneficiary". Both signatures must be witnessed by someone outside the family. This particular form also requires dating.

If you will send in whichever form you decide to complete together with your policy we will obtain the cheque in settlement in about two week's time.
