Mrs. Kiwa OMURA (Chiyokichi) - Reg. No. 14343

The only asset declared by the above Japanese when registering with this office was a \$1000.00 Sun Life Insurance policy, but this was not brought under control by the Custodian.

There is a claim on file by the Bank of Montreal against Chiyokichi OMURA, Mrs. OMURA's deceased husband, in the amount of \$229.00, but the claim stated that Shogo OMURA, File 8690 had instructed the Bank that monthly installments should be debited from his account in order to pay this account. File No. 8690 shows that this account was paid in full the 18th May, 1942.

A claim of \$1.00 was filed against C. OMURA by the GAZETTE, Haney, and they were informed that as Mrs. OMURA had no funds at this office with which to make settlement, collection would have to be made direct.

There is a memo on this file re chattels, but all chattels that were in the house in which Mrs. OMURA lived, belonged to her son, and were handled under his file.

This file reveals no other assets or liabilities and needs no further administration.

The above summary is certified to be in accordance with the information on file.
