Re: Policy No. 2,236,659

Thank you for your letter of December 16th giving us your policy number.

At the present time this year's premium is being carried as an automatic premium loan which bears interest at 6% per annum. Next year's premium when it falls due and is unpaid will be added to this loan and each year the same thing will happen and the assurance will continue in force as long as there is any value in the policy.

There is sufficient value to continue the assurance for at least another five years and during that time no doubt you will be in a position to either pay off the premium loan or reduce it substantially. Should your death occur while the premiums are being carried in this way, the face amount of \$1,000.00 less the premium loan would be made to your Beneficiary.

Should you decide to surrender your policy now you would receive a cash value of about \$155.00. In order to obtain this the attached application is to be signed by you where marked Assured and your signature witnessed by someone outside the family. Please be sure to date the form and return it to us together with your policy. About two weeks later we should be able to let you have a cheque in settlement.
