Re: Mrs. Toshiko TAHARA - Reg. No. 13447


The above Japanese declared no assets to the Custodian with the exception of a bank account at Mission, this however, was not brought under control by the Custodian.

Interest on Pacific Co-operative Union shares was credited to this account, as was also the refund of a B.C. Electric Railway Security Deposit for light. Both of these were, however, acknowledged as belonging to the father, Rinzo TAHARA, file No. 5453, and were only in her name as she did the clerical work for her father because of his inability to speak English fluently.

No liabilities were declared by the above Japanese nor were any filed against her.

No further administration is necessary on this file and it can therefore be closed.

Dear Madam:

According to the Pacific Co-operative Union records at Mission, there appears a shareholder, T. TAHARA, to be the holder of \$80.00, 1942 redeemable shares and \$40.00 unredeemable shares. Interest on these shares has been received at this office and is being held pending identification of the owner.

It would appear to this office that as your father was actually the operator of the farm property, he is really the owner of these shares, and that you might have registered them in your name using the initial "T" only, as you did your father's clerical work because of his lack of knowledge of the English language.

We are today writing your father and your brother, Toyotoshi, regarding this assumption, asking for their confirmation or disapproval.
