

By letter June 15th, 1943 Sukehachi MORI stated that he had no property in the Protected Area. However the file reveals that he asked on February 21st, 1943 for release of "1 Trunk containing bedding etc." Later, on Sept. 23, 1943, the Dept. of Labour, Japanese Division, issued a receipt for same, apparently for delivery to MORI at New Denver, B.C. No other information on file as to disposition of the Trunk.

Life Insurance:

Reference is made in file to Crown Life Insurance Co. policy No. 200908 in name of Hiroto MORI. This is same Insurance ✓ as declared on wife's file #8833 in Registration dated May 12th, 1942. According to letter March 15th, 1946 of Insurance Co., the Cash surrender value was paid without previous reference to this office. As Life Insurance did not vest with the Custodian no additional attention was required of this office.

LIABILITIES:

No Claims against or indebtedness of Sukehachi MORI are revealed on the file.
