GENERAL SUMMARY

Uhei TOKAIRIN, Deceased

Uhei TOKAIRIN died at Kelowna, B. C. on September 2, 1942. He is survived by his widow, Den, file #15054, and two sons, Hideo, file #10818 and Ichiso, file #8457.

The only asset the deceased declared to the Custodian was an insurance policy in the Montreal Life Insurance Company in the sum of \$1,000.00. From an inquiry to the Insurance Company it is learned that this policy was surrendered in May, 1942.

In July, 1945, the sum of \$2.11 was received for the credit of the account of Uhei TOKAIRIN, from the B. C. Electric Railway Company, being refund of Security Deposit for light. This sum is, today, being forwarded to Den TOKAIRIN, the widow, and the account of Uhei TOKAIRIN, deceased, in this office, is now closed.

No claims appear on either the file of the deceased or the file of his widow.
