
Please note that the above has been repatriated to Japan. At the time of repatriation, the following transactions took place:

Your file has been reviewed and the following is noted:

Hisaye FUJINO and yourself declared that you owned no property in the Restricted Area. You later acknowledged a debt of \$21.00 which you owed to Dr. E. J. Barrett of Mission, B. C. You paid this to him direct on June 15th, 1943.

You applied to the Crown Life Insurance Company for cash surrender value of your policy #361556 and the amount of \$78.00 was paid to you jointly on May 20th, 1943.

A cash surrender value in the amount of \$398.00 was paid to you and Sakutaro FUJINO, your father, on May 12th, 1943 by the Monarch Life Assurance Company for your policy #P59172.

You requested the Custodian to collect a debt of \$62.18 owed to you by Hachizo MORI. It was pointed out to you however, that this debt was outlawed and you were advised that this office could not take any action on this.

It would appear that we have accounted for all the property of every kind left by you in the Protected Area which vested in the Custodian, and in order that you may confirm this we are enclosing a stamped addressed envelope.




MONIES

Please refer to your letter of the 3rd inst. and to our reply of the 6th inst. relative to the above claim.

On receipt of your letter of the 3rd inst. we immediately wrote to FUJINO, reminding him that he promised to forward the above amount direct to Dr. Eacrett nearly a year ago. We are now in receipt of a reply from Mrs. FUJINO, in which she gives what seems to be conclusive evidence that this amount was remitted to Dr. Eacrett as promised. She claims having a receipt in her possession from Dr. Eacrett, dated June 20th, 1943, for this amount.

If the foregoing is found correct on further investigation we shall be obliged for a reply from you, indicating that it is so, as these people now think that this office has made a mistake.

On the day that we received her letter of the 10th inst. we also received a letter from James M. Campbell, Esq., Barrister representing Dr. Macrett, and in order that you will understand where the mistake occurred we quote his letter as follows:

"After receiving yours of March 6th I was today able to see Dr. Macrett who is very busy these days.

I find that he received \$21.00 direct from FUJINO in June 1943. He thought he had told me about this but evidently he overlooked it.

I am very sorry about this matter as I try to keep these things in shape but no doubt you understand how it is."

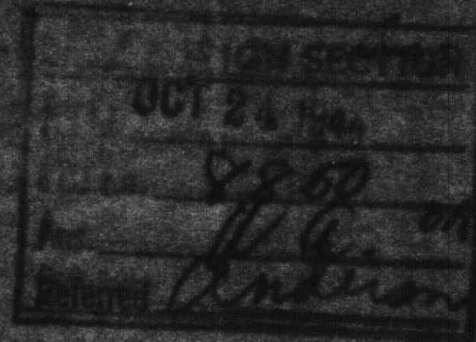
This, therefore, closes the matter and cancels the claim on your file.
