SHARES: She purchased shares in the Bralorne Mines Ltd. after her evacuation. In our letter of July 19/43 to the Royal Trust Co. we expressed no objection to such transaction.

No property interests other than those mentioned above are found on this file.

I have made arrangements with Mr. Albert H. Young, our lawyer, to have him take over the radio, in order to cut down any unnecessary expenses, therefore, please issue a Custodian's release for same. I do not wish to have this radio sold, simply for the reason that this was bought for me with the money awarded to me for academic award from high school at the time of my graduation.

As soon as the Custodian's release is issued, I will send my radio receipt to Mr. Young in order that he may claim my radio. Attached I am mailing you my mother's letter asking the Custodian to make out a cheque payable to Kelly's Piano House for the sum of Seventeen Dollars.
