Dear Sir:

As requested by you, we are enclosing herewith Custodian cheque in the amount of \$87.53, representing all the funds standing to your credit with this office.

This sum of \$87.53, as you are aware, is the proportionate share of the final distribution of assets of the Royston Saving Association on the basis of your 25 shares. The 25 Share Certificates which you sent to us have been placed on your file here.

We note from your file that in your declaration to the Custodian on May 13, 1942, you reported ownership of a box of fishing tackle. Our records show that this was shipped along with the effects of your mother through the British Columbia Security Commission in the summer of 1942.

The bank account, life insurance, Victory Bonds and War Savings Certificates, which you declared, did not come under the control of the Custodian.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian and, in order that you may confirm this and acknowledge the cheque, we are enclosing a stamped, addressed envelope.

This man, who was evacuated on June 29, 1942, signed a declaration to the Custodian on May 13, 1942. In his declaration he reported the following assets:

Chattels: One Paper box #1 (fishing tackle) stored at Cumberland Store in care of Matt Brown, Cumberland. Mr. Brown reported on August 20, 1942, that this box had been shipped along with the effects of this man's mother (File 8420) in the care of the B. C. Security Commission.

Bank Account: Royal Bank, Cumberland Branch, Acct. K227- \$500.00. This did not come under the control of the Custodian.

Life Insurance: Sun Life policy for \$1,000.00, in declarant's possession. This did not come under the control of the Custodian.

Bonds, Shares, Etc.: Two Victory Bonds of \$100.00 value and six \$4.00 War Savings Certificates, in declarant's possession. These did not come under the control of the Custodian.

In addition to the items declared, the file reveals that this man owned 25 shares in the Royston Saving Association. His account was credited with the sum of \$87.53 as proportionate share of the final distribution of assets of that association. The 25 Share Certificates are on this file.

This file reveals no other personal property of any kind whatsoever.
