This file reveals Mrs. KAGA owned no real property in any protected area of B.C., and did not carry any Fire Insurance.

CHATTELS:

Mrs. KAGA made her declaration to the Custodian on May 14/42 and was evacuated on May 18/42. She declared no chattels of any kind. However on June 6/42 we received a letter from the Pemberton Realty Corporation Ltd. stating that they had found the following chattels at 130 Gore Ave. where Mrs. KAGA had been residing.

a bookcase couch and some other odds and ends. several tables one chair

They stated that the tenant of these premises, Mr. Bouchard, was storing these chattels in one of the rooms. They also advised that Mr. Bouchard was willing to pay \$10.00 for them. We wrote to Mrs. KAGA on Oct.20/42 and asked her who owned these chattels, but received no reply. According to a memo from Mr. Spain dated Jan. 5/43 he states that the building is being demolished and apparently everything sold to housebreakers (imagine he means house wreckers). However no money was received in this office from same, and there is no further information on file as t what became of these. The husband declared no property whatsoever.

On April 6/43 the account of Mrs. KAGA was credited with the sum of RECEIVABLE: \$30.01, being proceeds from coupons of the 4% bonds of 1899 issue, Japanese Imperial Government. This is her only credit with this office.

BANK ACCOUNT: Mrs. KAGA declared a savings account in the Bank of Montreal, Main and Hastings branch, in the sum of \$1000.00. This was not brought under the control of the Custodian.

No property interests other than those mentioned above are found on this file.
