This man signed a declaration to the Custodian on May 14, 1942. He was evacuated on May 19, 1942.

In his declaration he reported a bank account in the Royal Bank of Canada, Vancouver, with a balance of \$450.00. This did not come under the control of this office.

He reported a \$1,000.00 policy with the Sun Life Assurance Co. in his own possession. This did not come under the control of this office.

He reported a debt owing to him of \$23.00 by a Mrs. Ross of Vancouver for groceries and fruit delivered. This was referred to Mrs. Ross who replied that this amount had been collected by a Japanese woman about the end of June, 1942.

This man surrendered a Chevrolet coach which was sold and the net proceeds of \$28.02 were credited to his account.

The account of this man was credited with the sum of \$1.82 received as refund of B.C. Electric Railway Co. security deposit for light.
