No. 00879 In her declaration of May 15th, 1942, this woman declared six policies with the Prudential Life, belonging to herself and her five children. These did not come under the control of the Custodian. The Royal Canadian Mounted Police reported that this woman had surrendered the camera and radio which are described in the Specified Articles Summary. The camera was mailed to Mrs. KITASAKI, by the Custodian, on January 17th, 1946. The cost of shipping this camera was 20 cents, which was charged to her account. The radio was sold for the net sum of \$43.36, which has been credited to her account. This file reveals no other assets of any kind.
