Re: Minoru OHASHI, Reg. No.13225

The 1937 Ford Pickup truck, registered in the name of this man, was stored at Johnston Motor Co. Ltd. garage, having apparently been repossessed by the Consolidated Finance Co. Ltd. to protect lien of \$409.62.

This truck was sold on October 30, 1942, to Johnson Motor Co.Ltd. for the sum of \$410.00. The appraised value of the truck was \$250.00.

On November 2, 1942, the sum of \$409.62 was paid from the proceeds of the sale to Consolidated Finance Co. Ltd. in settlement of the amount due under lien.

Administration expenses of the Custodian in connection with this car amounted to 38 cents, leaving no balance to be credited to Minoru OHASHI.
