Dear Sir:-

You will remember that you did not register until March 31st, 1943 at which time you declared as personal property "beds, table, chairs and a stove." we rather think this referred to your belongings in New Denver in which, of course, this office is not interested as we are only concerned with effects in the protected area.

Your wife did declare furniture left at 2155 Fernside Street but as she was not evacuated until some months after the declaration, we think she must have made her own arrangements in the meantime. At least our investigators were able to find nothing at this address and we asked her on August 2nd, 1943 to advise if we were not correct in assuming that she had disposed of everything.

We see that you disputed the claim of \$3.61 from the E. C. Electric and this office will not follow this matter further.

Finally, we have to advise you that we have sold for \$3.00 your one cylinder E. H. P. Bensid engine. We did have an offer for it of \$20.00 which we telegraphed you on February 26th, 1943 but to which you did not reply. The offer was subsequently withdrawn.

An appraisal of March 17th, 1943 showed that this engine was not complete and the piston was rusted solid in the cylinder. The value was put at \$15.00. A subsequent valuation described the engine as fit only as junk and worth \$2.50 only at the outside. It was advertised and the best offer that could be obtained was \$3.00. This, less cost of advertising in the amount of 75¢, has been credited to your account and we are,
