

GENERAL SUMMARY

Re: NISHIKAWA, Toshio - Reg. No. 03023.

The above signed a declaration to the Custodian on May 19, 1942 and was evacuated on June 29, 1942.

He declared 1 \$5.00 War Savings Certificate in his own possession. This was not brought under the control of the Custodian.

He also declared a Life Insurance Policy with the Prudential Life Assurance Co., the policy being in his own possession. This was also not brought under the control of the Custodian.

This file reveals no liabilities, nor does it reveal any property other than that mentioned above.
