This woman signed a declaration to the Custodian on May 20, 1942. She was evacuated on October 15, 1942.

In her declaration Mrs. KOYAMA reported one table, one bed and one chiffonier, stored with Mr. McLeod, 1182 Kelowna St., Vancouver. In October, 1942, Mr. McLeod informed us that Mrs. KOYAMA had taken the bed with her to Slocan. In October, 1943, Mr. McLeod informed us that the table and chiffonier had been shipped to Mr. & Mrs. KOYAMA, Slocan, B.C.

Mrs. KOYAMA reported 2 boxes of chinaware left with Mr. J. W. Wilson, 3408, Price Street, Vancouver, B.C. On September 13, 1943, Mr. Wilson handed to Bowman Storage Ltd. 3 cartons, said to contain dishes and silverware, for shipment to Mrs. KOYAMA, at Hamilton, Ont.

Mrs. KOYAMA reported \$20.00 in the Canadian Bank of Commerce, Vancouver Heights Branch. This was not brought under the control of the Custodian.
