

Re: MATSUMOTO, Shotaro and
HINATSU, Yohsiii.

I was past the Hinatsu property on Downs Road last week and I see that you have commenced ploughing. I realize that at as late a date as this you may not get a crop that will make you very much money, and for that reason I am prepared to make the rental as reasonable as possible.

As I told you when you were in the office, the annual taxes to be taken care of are \$45.00. There is another property just east of Hinatsu's, at the corner where Downs and Gladwin Roads meet, which the Japanese owner leased to Mr. S. D. Thompson of Abbotsford, last year, and this man was to have operated the place again for the present season, but evidently he has no intention of doing so. I believe after looking at the place that you might harvest sufficient strawberries this year to make it worth while for you to rent this along with the Hinatsu property for a couple of years on the basis of \$75.00 a year for the two places. You might look at the Matsumoto property and if you think that you can handle it along with Hinatsu's at the figure above mentioned, drop this office a line to that effect.
