Respecting the sale of the Studio Launge this, so you are so doubt suare, san sold at the request of your acthor she wrote to Morrow Realty Co. Ltd. in July 1942 to sell this article for the sus sentioned, temply \$18.00.

Beither you now your nother declared any chattels as being left at this property and although we wrote you on a number of conscious in an encessor to obtain from you that had been left, no reply was received from you, a certain quantity of simplianeous chattels were found on the premises by our Protection Repurtment and were removed and cold at Austion, Copies of the Austion Sheets are attacked, the net proceeds being \$40.47 and \$1.30, as mentioned above. In the circumstances these goods and the studio lounge are all that this office can be held responsible for, and in the absence of any information from you funds from the cale of those chattels were credited to your account. If it is agreeable to you and your author we propose not to truncfor those funds, namely \$99.77, to a separate account in her name but to format to you the balance of funds in your account, namely \$136.25, together with your \$1000.00 Yistory Loss Bood so that you can pay the amount due to your nother for the chattels sold.


