In reply to your letter of May 16th, addressed to Mr. Shears, we wish to inform you that neither Toichiro ASAOKA, the assured of the life policy referred to, nor Sotono ASAOKA, the beneficiary named in this policy, has been repatriated. A letter, dated March 31, 1947, received from Toichiro ASAOKA gave his address as Forest Grove, B. C.

There are no funds standing to the credit of either of these persons in Custodian Account. No assets known to belong to either are under the control of this office.

The files reveal that a claim was filed by Walkburn Neon Limited in the amount of \$120.00 against "Mrs. S. Asaka, Asa Cleaners, 1909 Yew Street, Vancouver." Recent evidence on file indicates that Toichiro ASAOKA did, at some time, operate Asa Cleaners, 1909 Yew Street. His declaration and the information received from the R.C.M.P. are that he operated a grocery store at 1905 Yew Street. Mrs. Sotono ASAOKA's file reveals no interest in Asa Cleaners or any other commercial enterprise. Her occupation is given as "housewife". No action has been taken by this office in regard to the claim.
