In reply to your letter of the 2nd instant we would advise that according to our records neither of the above evacuees have any assets.

We have practically no information on file regarding these evacuees except that \$20.62 was paid to Mr. Endo in March 1942, this being the balance due to him from the sale of a small fishing vessel after paying off a debt due to the Canadian Fishing Company Ltd.
