PERSONAL PROPERTY SUMMARY

File No. 9857

RE: Yukio ODE, Reg. No. 00388

This file reveals that Yukio ODE owned no real property in any protected area of B.C. and did not carry any Fire Insurance.

CHATELS: ODE made his declaration to the Custodian on May 22/42 and was evacuated June 8/42. He declared no chattels whatsoever, but there is a waybill on file dated March 23/42 consigning certain goods to Y. ODE at 23 Cordova St. These were apparently sent from Galiano, B.C. by S. MATSUMURA. As these evidently did not belong to Yukio and on checking through the ODE files, it does not seem to belong to any of them, it would appear that it belonged to either one of the "S. MATSUMURA". We are therefore putting a memo regarding these goods on each of these files.

MONEYS RECEIVABLE: He declared that he had about \$26.00 coming to him as refund of income tax. However he must have greatly overestimated the amount as we just received the sum of \$6.91 from the Provincial Collector and this sum was remitted to ODE on Aug. 17/43. *Dept of National Revenue*

His account has been credited with the sum of \$1.87, being a refund of 1% wage deductions for the first six months of 1941. This is his only credit with the Custodian at this date.

VICTORY BONDS & WAR SAVINGS CERTIFICATES: He declared \$50.00 or \$60.00 worth of War Savings Certificates and \$200.00 in Victory Bonds in his own possession. These were not brought under the control of the Custodian.

LIFE INSURANCE: He declared an insurance policy with the Sun Life Insurance Co. in the sum of \$1000.00, the beneficiary being his mother Kayano. We were advised by the Sun Life that this policy was a paid up policy on which there were no further premiums due. They also stated that the policy matured on Jan. 1, 1955, the maturity value being \$220.00. This policy did not come under the control of the Custodian.

No property interests other than those mentioned above are found on this file.
