OKUMURA made his declaration to the Custodian on May 22/42 and was evacuated on Sept. 17/42.

He declared only four \$10.00 War Savings Certificates in his own possession. These were not brought under the control of the Custodian.

His account has been credited with the sum of \$2.76, being a refund of 15 wage deductions for the first six months of 1941. This is his only credit with the Custodian.

There are no claims on file against OKUMURA.

No property interests other than those mentioned above are found on this file.
