GENERAL SUMMARY

Re: KOBAYAKAWA, Masao - Reg. No. 15435.

The above signed a declaration to the Custodian on May 23, 1942 and was evacuated on August 4, 1942.

He declared an insurance policy with the Prudential Life Insurance Co., the policy being in his own possession. This was not brought under the control of the Custodian.

However, on October 7, 1946, we received a request to pay the premium on the above mentioned policy as well as policies in the names of other members of his family. The premiums on these policies had previously been paid from the account of Takao KOBAYAKAWA, File 9942, brother of Masao. His account was then closed and as we had no funds on hand we returned the receipt books sent to us, to Masao KOBAYAKAWA.

This file reveals no assets other than those mentioned above nor does it reveal any liabilities.

This summary is certified to be in accordance with the information on file.
