GENERAL SUMMARY

Deceased.

Ichiro YAMAMOTO died at New Denver, B. C. on May 17, 1943. He was survived by his father, Kisaburo, file #5040, now deceased, and his mother Kaku, file #6032.

The only asset declared by the deceased was a Sun Life Insurance Policy in the sum of \$1,000.00, under which he stated his mother, Kaku, was the beneficiary. Upon his death, however, we were advised by the Sun Life Assurance Company that the beneficiary under the policy was the father of the deceased, Kisaburo Yamamoto. This office advised the Company that the Custodian would have no objection to payment of the death benefit under the policy being paid direct to the beneficiary.
