



According to our records, Mr. Kumakichi Nakagawa is the father of your wife, Mrs. Kane Nakagawa. This is confirmed by the declaration you made on your "JP" form when registering with the Custodian and also by the information given by your wife.

If this is the case, then it appears that you adopted your wife's family's name--will you please confirm if this is correct?

From information we have received from the Royal Canadian Mounted Police, your father's name is given as Kumakichi Nakagawa, and we presume this should read father-in-law. In order to complete our records, will you kindly let us have the full name of your father, and if we are incorrect in what we have stated above, please let us have the full name of your wife's father in addition to that of your own father.
