

Your file has been reviewed and the following noted:

When you registered with the Custodian, you declared no personal property. The radio was received by us from the R.C.M.P. and we sold it at public auction for the net sum of \$24.95, which amount is being remitted to you in our Custodian cheque enclosed herewith. With this remittance your credit in this office will be exhausted and we will close your account.

You declared a \$1,500.00 policy in the Occidental Life Insurance Co. and this policy was surrendered for cash in the amount of \$165.00, cheque for which amount was forwarded to you in our letter of June 9, 1943.

The Prudential Insurance Co. of America forwarded to us a cash surrender cheque in the amount of \$355.30, being surrender of their policy No. H-699912 in which you were the beneficiary. This cheque went forward to Misao NONOMURA, your wife and the insured on October 14, 1943.
