

Dear Sir:

Your file has been reviewed and it is noted that you declared on June 3rd, 1942, that you had no property of any kind whatsoever in the protected area of British Columbia.

However some chattels were removed from Carlisle Cannery of the Canadian Fishing Co. Ltd. among which was one item which appeared to belong to you. This article was sold at auction and the proceeds, namely, the sum of .36¢ was credited to your account. Custodian cheque for this amount is enclosed herewith.

It is noted that the sum of \$40.00 was remitted to you on January 25, 1943 being proceeds from a cohee net sold to the Canadian Fishing Co. Ltd. which you had apparently left with the Carlisle Cannery on your evacuation.

It would appear that this office has accounted for all the property of every kind left by you in the protected area which vested in the Custodian, and in order that you may confirm this and acknowledge the attached cheque, we enclose a stamped addressed envelope for your reply.
