GENERAL SUMMARY

File No. 10372

Jan. 8/47

RE: Wataru KAGAWA. Reg. No. 14425

Mr. KAGAWA registered with the Custodian on June 4/42 and was evacuated on June 22/42. He signed a yellow "No property" card stating he owned no property of any kind in the protected area of B.C. and none was found belonging to him.

He declared he owed Dr. E. G. Banno, dentist, the sum of \$25.00. On April 16/45 we wrote and asked him if he still owed this money and in his letter of April 23/45 he advised that he had settled this account earlier. We wrote to Dr. Banno to have this confirmed but his letter was returned marked "Removed".

The above summary is certified to be in accordance with the information on file.
