The deceased was a member of British Columbia Mutual Benefit Association and I understand that a cheque for \$2500 payable to Mrs. Sueno Ujihara the widow of the deceased and the beneficiary under the Certificate of Membership has been forwarded to you. I applied for a Dominion Succession duty release in respect of the certificate and forwarded this to B.C. Mutual Benefit Association along with the membership certificate and they have now issued their cheque in pursuance thereof. As the matter of payment by the B.C.
